**Course Description:** This 40-hour (5-day) basic Hand Held Ballistic Shield In-House Instructors Course is designed to provide all of the tactical skill sets, printed material, and training outlines required to teach officers, within their own agency, to deploy and utilize a hand held ballistic shield. This course focuses on the ballistic shield and related equipment, training and operational considerations when deploying the shield during law enforcement functions. Topics covered include Stances, Movement, Reload/Malfunction Drills, live fire, basic CQB, perimeter operations, arrest team strategies, building searches and other high-risk patrol operations, Officer/Citizen down rescues, Vehicle clearing/arrest/rescue, and instructor development. The course requires student instructors to learn, practice and demonstrate proficiency in the critical individual and team skill sets required to become certified as a shield operator and teach those skills sets to officers. Student instructors will be required to demonstrate the ability to pass a written test, and teach material from this course.

While not mandatory, it is suggested that departments enroll officers in this program that have previous firearms and/or tactical-related instructor experience. **Students for this program should be selected for the expectation that they will teach or coordinate their agencies in-house Hand Held Ballistic Shield program.**

This is a dynamic, fast-paced course geared towards officers who already have a basic knowledge of firearms handling/deployment and patrol tactics.

**\*\*\* Students are required to bring a notebook and writing utensil, ear/eye protection, duty leather, pistol, and flashlight, Patrol Rifle if assigned, 300 rounds handgun and 100 rounds long gun ammunition, 100 rounds FX Marking Cartridges and Marking converted weapons, long pants, boots, soft body armor, ballistic shields and helmets (if available), civilian shirt w/no police logos and water to drink during tactical exercises.**

## **Course Description:**

This course will assist/inform/update Detectives and Police Officers in the criminal procedure laws as they pertain to criminal investigations. This course examines procedural law, substantive law, case law, and photographic crime scene studies. Actual documented case studies are used to illustrate the current state of our laws.

# **BUILDING A BETTER POLICE REPORT**

## **Course Description:**

This 8- hour course will focus on enhancing an officer's report writing skills so that he or she may better submit clear, accurate, concise, and detailed primary case reports. Emphasis will be placed on detailing probable cause for an arrest, better providing investigators with essentials in primary reports so that follow-up may become more efficient and enhancing case building in a way that will aid prosecutorial success. The course will examine some of the top failure points of poorly written reports as seen by shift supervisors, and then provide a blueprint to organization to better build reports for the future. Added emphasis will be placed on the additional care and challenges presented when preparing initial reports for Domestic Violence, Criminal Sexual Assault, and when an officer has had to apply physical force in the field. This course is geared to both newer patrol officers who may be developing report writing experience, as well as those veteran officers who might benefit from enhancing their report writing skills. Learning will be done through both lecture and a practical writing lab. Students are encouraged to bring a laptop computer with Microsoft Word installed.

- Developing a winning mindset for proper report writing- Why it is THAT important!
- Top areas of report failure and how to correct them before you commit them
- Eliminating the "Cliffhangers" and communicating to your overall audience (cops, courts, lawyers, and social services)
- Implementing a fool-proof "Blueprint" for organizing any report, every time
- Making the link from describing events to establishing why actions were taken
- Strategy for reviewing reports prior to submitting them
- Challenges in preparing a primary Domestic Violence Report
- Challenges in preparing a primary Sexual Assault Report
- Documenting your use of force within your report

**Instructor:** Sergeant Phelan is a 22- year veteran of the Lockport Police Department, and a patrol Sergeant for the last 9. He graduated from the University of Illinois- Chicago earning a BA in Criminal Justice. He is also a graduate of the NUCPS School of Staff and Command. In addition to his formal education, he has served his department by managing the crime prevention/community outreach program where he was responsible for DARE, GREAT, community outreach, as well as writing and implementing a curriculum for his department's Citizen's Police Academy.

He was also the primary grant writer for Lockport in obtaining the Bureau of Justice Assistance's (BJA) Gang Resistance Education Grant, COPS Hiring Grant, Illinois Tobacco Enforcement Reimbursement Grant, and the Illinois Department of Transportation's Traffic Safety Grant. Those roles included the added responsibility of submitting grant proposals, timely progress reports, and preparing follow-up press-releases. He currently is the department's Field Training Manager where he is responsible for assisting in the selection of FTOs and reviewing the overall progress of recruits through the daily submitted observation reports.

**Course Description:** This 5-day, 40 hour program has been designed by the Illinois Law Enforcement Training and Standards Board to provide students with the required training in use of police personnel within the school setting in accordance with SB 2925 (PA 100-984). SROs must be police officers of law enforcement agencies who are to serve within a school setting pursuant to a memorandum of understanding between the employing law enforcement agency and a school district within the agency's jurisdiction. Any officer serving in this role as of January 1, 2021 must have a special certification issued by the Illinois Law Enforcement Training and Standards Board ("Board"). Such officers must have attended a special training, or attained a waiver by the Board, before they can serve in this role. **To be eligible for this special certificate, a full-time Illinois law enforcement officer must have been actively employed in a law enforcement position within the state for at least three years (five years for part-time officers) before enrolling in the course or requesting a waiver. Each such officer must also be of sound character, free of disciplinary concerns, and open to working with minors.**

Overview of juvenile law, Juvenile Court Act, role of the juvenile officer, special juvenile considerations, due process for juveniles, detention of juveniles, interrogating juvenile suspects, interviewing juvenile witnesses, rights of parents, SRO introduction, roles of SRO, school structure and hierarchy, school law, adolescent development/teen brain, communication, developing relationships among diverse students, special considerations and disabilities, criminal activity, law enforcement actions in school, ethical concerns, school design and safety, introduction to school threat response, school threat response case studies, role of SRO during a threat, recognizing an active threat, tactical maneuvering on school grounds, solo vs. group response tactics, clearing of school classrooms, identification and response to threat, post event, scenario trainings.

## Course Description

This one-day course of instruction focuses on the mechanics of installing the duty handgun Red Dot Sights (RDS) - pistol optic and the related shooting skills that may be required of law enforcement officers in their duties. Lawful and justifiable use of force actions by police officers are vital to citizen and officer safety and effectiveness. Community confidence and trust in law enforcement is vital and to gain that trust, the use of force, most importantly deadly force, by police officers must be lawful, justifiable, skillful, and effective when confronted by highly violent criminal offenders.

## **The following items **MUST** be brought to this course:**

- Soft Body Armor (MANDATORY)
- Handgun with optic to be installed or pistol/optic combination that can be mounted and remounted to get the full benefit of the hands-on mechanical portion of the class.
- Full duty belt with holster that fits the pistol with dot optic, and magazine pouches.
- Weather appropriate clothing – this is a partially covered outdoor range.
- Hydration – drinks for warm weather
- Eye and ear protection
- Billed Ball Cap
- Cleaning kit
- 300 rounds pistol ammunition
- Note-taking materials

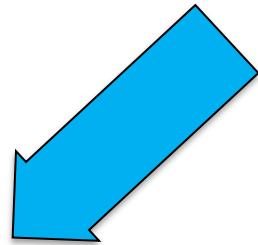

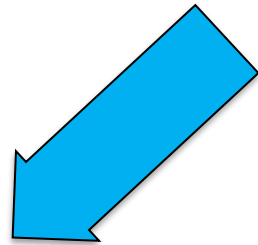

**Course Description:** The law enforcement environment can often be described as one that is a non-linear, open loop system, that happens at light speed. One where time can be either friend or foe. Operating in this environment creates stress which affects decision-making. Within this time-compressed environment officers often feel they need to act because they are there, rather than allowing the circumstances of the call to determine the urgency to act. The question is how to provide a strategy for officers to effectively control the stress response and to make lawful and ethical decisions. **Course Description:** This dynamic 4-hour program has been designed to provide law enforcement officers with a compelling historical analysis of the Holocaust that serves as a framework for further exploration of the ways in which abuses of authority evolve over time and how the rights of individuals must be balanced with the need for societal protection. The Law Enforcement Democracy Initiative is a proven program that impacts how police officers consider empathy, ethics, and morals in their decision-making process.

Participants will examine how changes in government policy and law shifted traditional functions of policing in German society to the implementation of human rights abuses and genocidal programs represented as national security and defense priorities. They will consider the effects these incremental policy shifts had on societal, occupational, and personal life, as well as the decision making of individual police officers during the Nazi era. Through examination of historical and contemporary case studies, students will consider the following issues:

- Moral and ethical decision-making
- Explore issues of racism, bias, and violence through exploration of contemporary case studies
- Discuss the dangers of silence and indifference.
- Challenges inherent to the law enforcement profession
- Responsibilities officers have to society and each other
- Stereotyping and the abuse of authority
- Empathizing and connecting with individuals
- Current Hate Crime legislation, reporting considerations, and review of high-profile hate crimes

Class will conclude with a Holocaust survivor's eyewitness recounting of events as they happened during the Nazi era.

## Instructors:

**Dr. Susan Woollen:** I worked in higher education for over 30 years, and I retired from the Department of Criminal Justice Sciences (CJS) at Illinois State University in 2019. I was an administrator in CJS and co-taught a study abroad course on genocide using the Holocaust as a case study. I also taught classes in the College of Education at ISU. My early research focused on equity in education and women's leadership in higher education. Currently, a former colleague and I are conducting research that applies a criminological theory to explain the causes of genocide and how to prevent future cases. I have co-presented results of this research to the American Society of Criminology, as well as to the United Nations Office on Drugs and Crime. I am also actively involved with the Illinois Holocaust Museum and Education Center as a docent, facilitator, and member of the Second-Generation Speakers' Bureau (my mother was a survivor of the atomic bomb that was deployed over Nagasaki, and I present her pre-war, war, and post-war experiences to community members).

**Jacqueline L. Schneider** is Professor and former Chair in the Department of Criminal Justice Sciences at Illinois State University, Normal, IL. She received her undergraduate degrees in law enforcement and in criminal justice from the University of Cincinnati. She received her Master's in Public Administration from The Ohio State University and then returned to the University of Cincinnati on scholarship to work on her doctorate in Sociology, which she received in 1995. She's taught and conducted research in the US and in England where her work on stolen goods markets has been put forward as best practice in and has attracted interest from policymakers in various countries. In addition to her many grants, she was the first recipient of the Home Office's Innovative Research Challenge Grant (UK) and she received an outstanding teaching award in the United States. Her published works include numerous academic papers and chapters in books. Her book, *Sold into Extinction* received the Distinguished Book Award, 2012 from the American Society of Criminology's Division of International Criminology. Her current research area pertains to the role criminal justice organizations played in the Holocaust and other genocides. Previous research topics included stolen goods markets, and the illegal trade in endangered flora and fauna.

The purpose and scope of this training is to highlight the historical and contemporary artifacts of the crime and terror nexus and how Human Terrain Mapping and Behavior Pattern Recognition (HTMBPR) compliments efforts to thwart criminal and terrorist activities in the United States. HTMBPR is a science-based predictive analysis and proactive decision-making model. It is based upon lessons learned from the development of Human-Behavior Pattern Recognition and Analysis programs for the Department of Defense. HTMBPR focuses on developing advanced critical thinking, the decision-making algorithm, biases, and the six layers of human behavior. It provides a framework for Law Enforcement Officers to observe, articulate, document, and defend decisions they make while performing their duties by providing officers with the knowledge, skills, and abilities to:

- 1) Observe a situation, orient themselves with it, and make sound practical decisions in accordance with law and agency policy and procedure, and
- 2) Then take legal, moral, and ethically appropriate actions.

Contained within this training will be small group breakouts, written test, and video practical applications.

**Course Description:** This is a 3-day, twenty-one hour program on the Reid Technique of Interviewing and Interrogation®. The course includes; interview and interrogation preparation, behavior symptoms, the Reid® Behavior Analysis Interview (B.A.I.) and "The Reid Nine Steps of Interrogation" which include:

### **Interview and Interrogation Preparation**

The style, appearance and approach of the successful interviewer and interrogator will be covered, as will the room settings conducive to these activities.

### **Behavior Symptoms**

Differences in verbal and nonverbal behavior between innocent and deceptive persons often can be observed, and are thus indicative of whether or not a suspect is telling the truth. A guilty suspect makes a conscious decision to resist your effort to get at the truth. In trying to maintain a structure of verbal lies, however, that suspect most often develops internal conflicts and tensions which manifest themselves in nonverbal behavior. Thus, body movements, facial expressions, eye contact, attitudes, posture and grooming gestures can indicate whether the subject is telling the truth or lying. Nonverbal indicators can also be used to determine whether the suspect under interrogation is listening, maintaining a defiant attitude or is ready to confess. You will learn how to observe and assess critical behavior symptoms and use those assessments to determine whether to move on to the next step of the interrogation.

### **Reid® Behavioral Analysis Interview "(B.A.I.)**

The information developed through use of the standard investigative questions of "who," "what," "when" and "how" is often not adequate — even in combination with physical evidence — to identify the wrongdoer. The Reid Behavioral Analysis Interview is a technique that uses a structured set of non-accusatory behavior-provoking questions developed as a result of many thousands of interviews. The B.A.I. makes it easier to determine whether the suspect is telling the truth about involvement in the matter under investigation, and is flexible enough to be used in cases ranging from employee theft to homicide.

### **The Reid Nine Steps of Interrogation®**

The nine-step approach to a successful interrogation has been developed by John E. Reid and Associates through extensive research and practical experience over a period of 60 years. Because of the subject's importance, approximately half the classroom time in the seminar is devoted to the interrogation process and detailed examination of each of the nine steps.

This includes increasing mental toughness, enhancing tactical skills, preventing injury, self-deescalation, regulating the nervous system and more. The result of consistent training in YFFR Protocol will not only lead to better performance and stress management but an increase in mindful responses versus emotional reactions with interpersonal communication.

This course will introduce the trainee to the basic concepts of yoga, mindfulness, and resilience, functions of the brain and nervous system, as well as the principles of the YFFR Protocol that make it job-specific and culturally informed. Attendees will learn techniques to use right away along with resources to continue their training.

1. Defiant stage: seven proven tactics to move suspects out of this stage
2. Neutral stage: four proven techniques to get the suspect to listen to the interrogator's themes
3. Acceptance stage: three specific techniques that will dramatically increase admissions of guilt

People who commit crimes do so to fulfill certain needs. What needs were satisfied is based upon the case facts, evidence and results of the interview — types of needs that will be thoroughly discussed are:

- Real need crimes
- Impulse need crimes
- Esteem need crimes
- Lifestyle need crimes

The Advanced Seminar will also address the following specific problem areas for some but not all interrogations:

- Juvenile interrogations
- Interrogation regarding guilty knowledge
- Playing one suspect against another
- Interrogation on multiple crimes

It is important to have individuals in law enforcement who can utilize effective strategies, insuring public and personal safety. The Crisis Intervention Team (CIT) training provides officers with education about mental illness and other behavioral disabilities as well as providing skills and tools for effectively and safely interacting with someone who is experiencing a crisis.

**Course Description:** Participants of this voluntary, 40-hour training program, receive intensive training on recognizing and addressing individuals in the community who have a mental illness or other behavioral health crisis. The CIT training program is an in depth, specialized course for officers with at least one-year of non-probationary experience. The five-day course includes presentations by behavioral health specialists, experienced field officers and representatives from regional service providers. Officers will receive training in topics such as mental illness/signs and symptoms, co-occurring disorders, child and adolescent issues, medical conditions and psychotropic medications, and law enforcement response and legal issues. They will also learn advanced communication and de-escalation techniques, partake in valuable exercises, have a unique opportunity to participate in discussions with individuals who have a mental illness and or their family members and given an opportunity to exercise their skills in realistic scenario role plays.

The key components of this course cover the following:

- Officers are exposed to the dynamics of mental illness, developmental disabilities, child and adolescent disorders, elderly individuals with behavioral issues, returning combat veterans, people who have excited delirium, and people with substance abuse/co-occurring disorders. This training will allow officers to make quick and effective decisions utilizing options they have to resolve the crisis.
- Officers are exposed to the experiences, viewpoints and concerns of persons with mental illnesses (consumers). Officers will meet with consumers in order to gain their perspective and learn from them.
- Officers receive instruction and demonstrations in basic listening and responding skills along with crisis interventions strategies. Real life crisis scenarios provided by trained professional actors with the assistance of state-certified CIT officers are presented to officers for them to demonstrate their resolution skills.
- **The scenario-based training will take place on Thursday, October 30<sup>th</sup>; attendees will be required to wear their "department uniform of the day" for their current assignment.**

**Course Description:** This course was designed to familiarize officers with various aspects of death investigations from scene response through case closure. In Death Investigation, patrol officers and detectives will gain a comprehensive understanding of their roles in death investigations. Instruction includes a focus on collaborating with jurisdictional death investigation agencies, recognizing common causes of death, processing scenes based on various situational factors, and documenting and preserving critical evidence. Review of case studies will encourage critical thinking regarding application of basic investigation techniques and evidence technician skills. Other topics include attendance at autopsies, the process of a coroner's inquest, report writing, and making notification.

## Course topics include:

- Understand the fundamentals of a complete and thorough death investigation from initial arrival at the scene through case closure.
- Learn and retain the basic tasks involved in a death investigation including handling of evidence, collecting relevant case information from various sources, working with decedent families, and collaborating with death investigation agencies.
- Recognize the importance and value of working with their jurisdiction's death investigation agency including post-scene follow up and obtaining autopsy and toxicological evidence.
- Know the various and unique steps involved in a death investigation based on initial observations and suspected manner of death.
- Obtain the skills necessary for performing an on-scene body examination to ensure an accurate cause and manner of death are established.
- Learn the best practices of working with next of kin including making notification, providing resources, and following up after initial contact.

**Course Description:** This 2-day, 16-hour program has been designed by the Illinois Law Enforcement Training Standards Board to provide students with the required training in use of police personnel within the school setting in accordance with SB 2925 (PA 100-984). SROs must be police officers of law enforcement agencies who are to serve within a school setting pursuant to a memorandum of understanding between the employing law enforcement agency and a school district within the agency's jurisdiction. Any officer serving in this role as of January 1, 2021, must have a special certification issued by the Illinois Law Enforcement Training and Standards Board ("Board"). Such officers must have attended a special training course or attained a waiver by the Board before they can serve in this role.

This course consists of the three primary components addressed in the curriculum: Juvenile Law, Officer and Youth Interactions, and School Threat Response. Students will participate in guided discussions/lectures, interactive activities, and performance-based exercise.

**Instructors:** This course will be taught by a team of Instructors. Lead Instructor, Danielle Butts is the Founder and Executive Director of All Our Children's Advocacy Center. She has been a Forensic Interviewer for 20 years and conducted over 4,000 interviews. **Course Description:** The law enforcement environment can often be described as one that is a non-linear, open loop system, that happens at light speed. One where time can be either friend or foe. Operating in this environment creates stress which affects decision-making. Within this time-compressed environment officers often feel they need to act because they are there, rather than allowing the circumstances of the call to determine the urgency to act. The question is how to provide a strategy for officers to effectively control the stress response and to make lawful and ethical decisions. The answer is two-fold; 1) Emotional Intelligence and 2) The Adaptive Decision-Making Model. The Adaptive Decision-Making Model addresses lawful and ethical decision-making. The model's foundation is the 4<sup>th</sup> Amendment Search and Seizure law. It asks, "Does the officer have the lawful authority to act or search or arrest?" Then examines the urgency to take an action, or what threshold of "government intrusion" will be acceptable to accomplish the law objective? This engaging workshop provides the attendees with strategies to increase their emotional intelligence competencies and develop their critical thinking and decision-making skills.
