# **Social Media & Online Investigations**

#### **Course Description:**

Law Enforcement Officers, Police Crime Analysts, and Prosecutors will learn the skills needed to conduct internet-based investigations along with obtaining data from Social Media companies with a court order. Students will be introduced to Open-Source Intelligence Techniques (OSINT) that can be used to obtain evidence and information about offenders without the need for legal orders. Students will be introduced to Internet Protocol and the Dark Web. Advanced Google Search Techniques will be discussed along with tips on creating online identities for Online Investigations. Students will work with a forensic mapping tool to analyze Snapchat geolocation data.

Students will need a laptop or windows tablet (NO IPAD) with internet capability and Google Earth Profession Desktop installed on their laptop. Bring a mouse to use with the laptop.

# **Upon Completion:**

Participants will have a better understanding of different Social Media companies commonly used and how to identify their target's Social Media accounts. Participants will know how to preserve and obtain data that is stored by Social Media companies either through a Court Order or through Open-Source Techniques. Participants will be knowledgeable in the device location data kept by some Social Media Companies and how this location data can be obtained and forensically mapped. Participants will know about techniques on how to create anonymous online profiles that can be used to investigate subjects. Participants will know more about Internet Protocol and how perpetrations can be identified by IP addresses. Participants will know how to go beyond the normal Google Searches by using Advanced Google Search techniques. Participants will have knowledge of over 250 free websites that can be used to learn valuable intelligence on any type of investigation.

**Instructor:** Jeff German is a Detective with the City of Joliet, Illinois Police Department. Detective German has over 20 years' experience as a Police Officer and over 10 years' experience as a Detective and an Investigator for the Will/Grundy Major Crimes Task Force. Detective German is a subject matter expert in Cellular Record & Geolocation Analysis, Certified Forensic Mobile Examiner, Certified Forensic Video Technician, Certified Vehicle System Forensic Technician & Examiner, Fire Investigator, Lead Homicide Investigator, and Certified Evidence Repair Technician.

#### **Course Description:**

This training features interactive lectures and discussions of actual case histories, videos, and laws specific to homicide investigations. This comprehensive seminar provides instruction in conducting investigations and prosecuting death cases from the start of the investigation, through evidence collection, press conferences, trial testimony, and ultimately conviction.

This class uses a combination of actual homicide case studies, so participants work through a case from the beginning, through case closure. **The training provides participants the techniques and structure to** *lead* **a professional and lawful investigation.** 

"Effective 01-01-2012, under 50 ILCS 705/10.11, only law enforcement officers who successfully complete the Board certified 40-hour Lead Homicide Investigator training program may be assigned as lead investigators in homicide investigations." This course fulfills the requirements.

**Instructor: Lou Tessmann**, CFI retired from the Waukegan (Illinois) Police Department after 23 years of service in a wide variety of assignments, including patrol, investigations, training, and ultimately Deputy Chief of Police. Lou is a 26-year veteran of the United States Marine Corps, retiring as a CWO-4. In addition to his service in Vietnam he was activated for Desert Storm and Desert Shield and has received numerous military awards including the Naval Commendation Medal. Lou began his career as a police officer with the City of Waukegan assigned to the patrol division. He was later assigned to the detective bureau for nine years and as a juvenile officer for one year. Lou also served as the Commander of the elite Lake County Major Crime Task Force. The task force works on major criminal investigations relating to homicides, kidnappings, and police-involved shootings. During his career, he has conducted thousands of interviews and interrogations. Most noteworthy, Lou has obtained over 80 homicide confessions during his career with only three instances where he was unable to obtain a confession from the homicide suspect.

**Jeffrey J. Pavletic** is a subject matter expert and an award-winning trial attorney who has built a reputation of integrity and exceptional skill in the courtroom. As a prosecutor over the past three decades, he has tried countless cases to victory (including approximately 175 jury trials with a concentration in homicide and violent crime). In addition to trying some of the highest profile and complex cases that have occurred in the history of Northern Illinois, Jeff was Chief of the Felony Review Division, and was the First Assistant State's Attorney for the Lake County (Illinois State's Attorney's Office).

Crisis Intervention Team Training 40 hours

**Purpose:** Law enforcement officers are generally the first responders to crisis events. It is important to have individuals in law enforcement who can utilize effective strategies, insuring public and personal safety. The Crisis Intervention Team (CIT) training provides officers with education about mental illness and other behavioral disabilities as well as providing skills and tools for effectively and safely interacting with someone who is experiencing a crisis.

**Course Description:** Participants of this voluntary, 40-hour training program, receive intensive training on recognizing and addressing individuals in the community who have a mental illness or other behavioral health crisis. The CIT training program is an in depth, specialized course for officers with at least one year experience. The five-day course includes presentations by behavioral health specialists, experienced field officers and representatives from regional service providers. Officers will receive training in topics such as mental illness/signs and symptoms, co-occurring disorders, child and adolescent issues, medical conditions and psychotropic medications, and law enforcement response and legal issues. They will also learn advanced communication and de-escalation techniques, partake in valuable exercises, have a unique opportunity to participate in discussions with individuals who have a mental illness and or their family members and given an opportunity to exercise their skills in realistic scenario role plays.

The key components of this course cover the following:

- Officers are exposed to the dynamics of mental illness, developmental disabilities, child and adolescent disorders, elderly individuals with behavioral issues, returning combat veterans, people who have excited delirium, and people with substance abuse/co-occurring disorders. This training will allow officers to make quick and effective decisions utilizing options they have to resolve the crisis.
- Officers are exposed to the experiences, viewpoints and concerns of persons with mental illnesses (consumers).
   Officers will meet with consumers in order to gain their perspective and learn from them.
- Officers receive instruction and demonstrations in basic listening and responding skills along with crisis interventions strategies. Real life crisis scenarios provided by trained professional actors with the assistance of state-certified CIT officers are presented to officers for them to demonstrate their resolution skills.
- The scenario-based training will take place on <u>Thursday, October 17<sup>th</sup></u>; attendees will be required to wear their "department uniform of the day" for their current assignment.

**About the Instructors:** The course will be conducted by a diverse group of law enforcement and behavioral health professionals, including active CIT officers from various parts of the State of Illinois. An essential part of the CIT course is scenario-based skills training with crisis scenarios provided by trained professional actors. All scenarios are facilitated and evaluated by certified CIT officers.

**Course Description:** The goal of this program is to provide investigators with the skills necessary to identify, document, collect, and preserve bloodstain evidence and effectively integrate it into their cases. It provides the foundation for investigators to identify, document, collect, and handle bloodstain evidence in any criminal case. Students will be given detailed explanations of the most up-to-date, scientifically sound methods for identifying, documenting, and collecting bloodstain evidence encountered by law enforcement crime scene service units. It will build upon basic blood evidence training students receive in standard 40 Hour Basic Evidence Technician courses and will introduce advanced methods for interpreting and processing such evidence.

The lecture portion of this program is minimal so students can maximize time spent on hands-on exercises meant to build upon practical skills that will be immediately applicable on the job.

**Course Description:** This is a 3-day, twenty-one hour program on the Reid Technique of Interviewing and Interrogation®. The course includes; interview and interrogation preparation, behavior symptoms, the Reid® Behavior Analysis Interview (B.A.I.) and "The Reid Nine Steps of Interrogation" which include:

#### **Interview and Interrogation Preparation**

The style, appearance and approach of the successful interviewer and interrogator will be covered, as will the room settings conducive to these activities.

#### **Behavior Symptoms**

Differences in verbal and nonverbal behavior between innocent and deceptive persons often can be observed, and are thus indicative of whether or not a suspect is telling the truth. A guilty suspect makes a conscious decision to resist your effort to get at the truth. In trying to maintain a structure of verbal lies, however, that suspect most often develops internal conflicts and tensions which manifest themselves in nonverbal behavior. Thus, body movements, facial expressions, eye contact, attitudes, posture and grooming gestures can indicate whether the subject is telling the truth or lying. Nonverbal indicators can also be used to determine whether the suspect under interrogation is listening, maintaining a defiant attitude or is ready to confess. You will learn how to observe and assess critical behavior symptoms and use those assessments to determine whether to move on to the next step of the interrogation.

The information developed through use of the standard investigative questions of "who," "what," "when" and "how" is often not adequate — even in combination with physical evidence — to identify the wrongdoer. The purpose and scope of this training is to highlight the historical and contemporary artifacts of the crime and terror nexus and how Human Terrain Mapping and Behavior Pattern Recognition (HTMBPR) compliments efforts to thwart criminal and terrorist activities in the United States. HTMBPR is a science-based predictive analysis and proactive decision-making model. It is based upon lessons learned from the development of Human-Behavior Pattern Recognition and Analysis programs for the Department of Defense. HTMBPR focuses on developing advanced critical thinking, the decision-making algorithm, biases, and the six layers of human behavior. It provides a framework for Law Enforcement Officers to observe, articulate, document, and defend decisions they make while performing their duties by providing officers with the knowledge, skills, and abilities to:

Operating in this environment creates stress which affects decision-making. The question is how to provide a strategy for officers to effectively control the stress response and to make lawful and ethical decisions. - Know and carry out appropriate administrative procedures for the Horizontal Gaze Nystagmus test.
- Know and recognize typical clues of alcohol and/or other drug impairment that may be seen during administration
  of the Standardized Field Sobriety Tests.

The phenomenon of the school shooter in our schools is at an all-time high. With the advent of depression, bullying and suicidal tendencies as a result, first responders in our school and police departments must be trained to handle these situations with immediacy and GREAT sensitivity. The goal MUST be to identify and intercept the criminal activity before the school shooter is able to take action. The goal of this training is to empower school administrators and Law Enforcement how to gather digital evidence against the aggressor so they may find out who the perpetrator is and take action immediately after the comment or posting is made by the aggressor. The LEO/ School Administrator will learn the fundamentals of investigating social media and internet related crimes that deal with domestic terrorism. - Understand how to obtain IP's, screen names, screen captures, email headers, and statements for the investigation. (continued)

- Discuss the laws in that state in reference; Terrorist Threat, Falsely Making a Terrorist Threat, Swatting and Causing a Catastrophe.
- Overview of computer and cell phone forensics and when it is appropriate to seize these items from a victim or a suspect to be analyzed.
- Once the suspect is identified, the importance of arrest, interrogation and mental evaluation.

In Death Investigation, patrol officers and detectives will gain a comprehensive understanding of their roles in death investigations. Instruction includes a focus on collaborating with jurisdictional death investigation agencies, recognizing common causes of death, processing scenes based on various situational factors, and documenting and preserving critical evidence. Review of case studies will encourage critical thinking regarding application of basic investigation techniques and evidence technician skills. Other topics include attendance at autopsies, the process of a coroner's inquest, report writing, and making notification.

#### **Course topics include:**

- Understand the fundamentals of a complete and thorough death investigation from initial arrival at the scene through case closure.
- Learn and retain the basic tasks involved in a death investigation including handling of evidence, collecting relevant case information from various sources, working with decedent families, and collaborating with death investigation agencies.
- Recognize the importance and value of working with their jurisdiction's death investigation agency including post-scene follow up and obtaining autopsy and toxicological evidence.
- Know the various and unique steps involved in a death investigation based on initial observations and suspected manner of death.
- Obtain the skills necessary for performing an on-scene body examination to ensure an accurate cause and manner of death are established.
- Learn the best practices of working with next of kin including making notification, providing resources, and following up after initial contact.

**Course Description:** This course goes more in depth than the offered 8-hour course, with added discussion and exercises. It is designed to provide law enforcement officers with a comprehensive overview on various crimes against children involving child abuse. Each topic will be discussed in a way that professionals working child abuse can recognize and distinguish various offenses involving children, appreciate their unique characteristics, dispel common myths and outdated practices, discern how injuries may or may not present, understand the complexities involved and learn how to overcome the challenges these cases present. This session will also provide guidance with responses to these specific calls while acknowledging the unique characteristics and discuss how to work with an MDT (Multidisciplinary Team) for the best outcome. The importance of an adequate investigation will be highlighted on cases where victims are unable to tell their story. The focus will include real case scenarios of incident investigation, suspect interviews, child interviews, non-offending caretaker/witness interviews, crime scene evaluation and creation of timelines. The most common forms of physical abuse will be discussed, which will include bruises, burns, fractures and abusive head trauma as well as child death investigations.

#### Course Goals:

- Officers can recognize and distinguish offenses of child maltreatment
- Officers can appreciate how responses may appear and the unique characteristics of crimes against children, including challenges and barriers specific to child victims
- Officers will learn about Adverse Childhood Experiences, trauma informed responses and understand how these responses are related to epigenetics and long-term outcomes including intergenerational trauma responses
- Dispel common myths and outdated practices with physical abuse
- Recognize the importance of trauma informed and victim centered responses
- Discern how injuries may or may not be present
- Understand the complexities involved with evidence in physical abuse and death investigations
- Appreciate the unique judicial processes involved with crimes against children, which includes criminal court, juvenile court, family court and DCFS hearings
- Discuss the involvement of a child forensic interview, a children's advocacy center and child abuse specialists
- Learn how to overcome challenges these types of crimes present
- Demonstrate how to identify and utilize the evidence to interpret who and what caused a child's injuries and/or death. (CONTINUED)

- Explore the necessary MDT investigative process needed to determine mechanisms behind serious abusive injuries and death investigations
- Apply medical aspects of child maltreatment to a comprehensive MDT investigation of child abuse and/or death

**Course Description:** The primary focus of the course will be to provide patrol officers and patrol supervisors with the specialized skills, knowledge and abilities while making or assisting on traffic stops needed to recognize the specific clues of persons involved in criminal, terrorist or other illegal activities. Content will include making the initial observation, contact, and safety protocols for traffic stops. Officers will learn and practice the strategic skill set needed for properly searching multiple suspects on the street. **Course Description:** Officers will discuss and visualize the concept of Tactical Emergency Casualty Care as it applies to law enforcement tactical situations and the treatment of injured officers. Officers will learn and demonstrate specific treatments and interventions for the most commonly encountered wound patterns.

Officers are asked to bring clothing appropriate for weather conditions for scenario training.

On completion of the course, each participant will receive a Medical Patrol Officer Kit for duty use. Each kit contains: One C-A-T Combat Application Tourniquet, an OLAES Emergency Trauma Dressing and a Hyfin Vent Compact Chest Seal.

#### Upon completion of this period of instruction, officers will be able to:

- Identify the concepts of Tactical Emergency Casualty Care, its use in the law enforcement environment and how this concept differs from historically taught conventional First Responder medical treatment practices.
- Identify the most commonly sustained officer injuries and preventable causes of death.
- Identify the importance of mindset and maintaining situational awareness when wounded and when treating fellow officers.
- Identify signs and symptoms of airway problems and demonstrate airway interventions.
- Identify signs and symptoms of serious bleeding and demonstrate control interventions.
- Identify signs and symptoms of shock and demonstrate prevention and treatment interventions.
- Perform a Casualty Evaluation/F.A.S.T. Rapid Trauma Assessment and tactical evacuation.
- Plan and perform a vehicle and non-vehicle officer down rescue/extraction in a high-threat environment.

**Course Description:** This four-day hands-on, problem-based learning course is specifically designed for first-line patrol and administrative support services managers responsible for supervising and managing Field Training Officers and probationary law enforcement employees. Instruction will include all revisions to the Process.

The course emphasizes the necessary components of supervising probationers and Field Training Officers at the patrol shift level to ensure that administrative guidelines and legal requirements are met. The course highlights two essential supervisory responsibilities: (1) the ability to comprehensively examine probationer performance documentation in accordance with the **totally revised** standardized Field Training and Evaluation Process assessment guidelines, and (2) auditing the probationer's on-the-job training to ensure the Field Training Unit utilizes the most appropriate instructional techniques for training task mastery and when necessary, corrective action. **Course Description:** In most jurisdictions, traffic crashes account for more lives lost, more injuries and more property damage than all criminal activity combined. To effectively implement crash prevention programs and improve quality of life, law enforcement agencies need to know the who, what, where, when and why of crash occurrence.

The moments immediately following a traffic crash are crucial, and only a well-trained crash investigator knows how to identify and collect the necessary information at the crash scene and to begin the interpretation of that evidence.

Crash investigators must work quickly and confidently to preserve significant physical results before the crash scene is altered or evidence disappears. They must anticipate what information will be needed for enforcing traffic laws, planning crash prevention programs and possible case litigation. In addition, they must properly document the atscene information and evidence because once the scene is cleared, the evidence might be impossible to recover.

Crash Investigation 1, based on J. Stannard Baker's world-renowned text, Traffic Crash Investigation, is an in-depth study of the skills needed to systematically investigate a traffic crash. Techniques for recognizing and properly recording roadway and vehicle crash evidence are thoroughly presented. Students learn to take measurements and photographs of the crash scene and to create sketches and after-crash diagrams. Crash Investigation 1 also addresses how the collected data are used to reconstruct crashes. Finally, the use of electronic devices to collect and record atscene data is also introduced.

#### **Course Topics:**

- Preparation for traffic crash investigation
- Information from and about people
- Information from vehicles
- Information from roads
- Measuring and mapping the crash scene
- Photographing the crash scene and damaged vehicles

• For this updated program, students will develop a new case study. Photographs and exhibits have been updated, and classroom instruction now includes how the latest generation of vehicle electronics - including data recorders, traction and stability controls, multiple airbags, etc. - affect both the crash and the crash investigation

**Course Description:** This course uses tactical breath work, physical drills, and cognitive behavioral therapy resulting in optimal functioning of the entire psychophysiological system. This includes increasing mental toughness, enhancing tactical skills, preventing injury, self-deescalation, regulating the nervous system and more. The result of consistent training in YFFR Protocol will not only lead to better performance and stress management but an increase in mindful responses versus emotional reactions with interpersonal communication.

This course will introduce the trainee to the basic concepts of yoga, mindfulness, and resilience, functions of the brain and nervous system, as well as the principles of the YFFR Protocol that make it job-specific and culturally informed. Attendees will learn techniques to use right away along with resources to continue their training.

## **Course Objectives:**

- 1. Explain yoga, its original intent, and address misconceptions.
- 2. Formulate the steps needed to practice mindfulness.
- 3. Outline the 3 Principles of Resilience Training.
