TRI-RIVER POLICE TRAINING REGION FY2021 ANNUAL REPORT

January 1, 2022

FY21 started off with an unknown future regarding state funding from ILETSB due to the change in the collection of the Traffic Surcharge Fund. The original budget awarded Tri-River \$422,169.35 in State funding. By the end of the fiscal year, Tri-River had received a total of \$324,699.06 in State funding. This left Tri-River almost \(^{1}\delta\) or \$97,470.29 less than originally budgeted.

In November 2020, the Country continued to be affected by the COVID19 pandemic shutting down all in-person training from November through January. Tri-River rescheduled these training courses from April 2021 through the end of the fiscal year. During the time of postponed courses, Tri-River worked with member agencies by concentrating on certifying their in-service training to assist them with required mandates.

Tri-River continued to assist our members with completing current training mandates. We also liaised between the Training Board and member departments regarding the new Safe-T Act legislation which changed the in-service training mandates for officers and their departments. Training mandate compliance continues to play a significant role in determining the types of classes we schedule. Tri-River has worked diligently to ensure our member departments the opportunity to meet the training mandates required for their Officers.

During Fiscal Year 2021, Tri-River continued to assist our members in meeting their required mandates through their own in-service department training. We continued to have their in-house training certified for mandate coverage by entering their classes

into the LETM database and providing certificates after classes were completed. As of June 2021, 29 member departments were utilizing a monthly on-line computer-based training program which was certified by the Training Board monthly. Each department's on-line monthly training is entered into LETM as an individual class which has resulted in a significant increase in data entry on the part of our staff. Tri-River anticipates more member departments will take advantage of on-line training as well as in-service departmental training to meet required training mandates.

In FY2021 we hosted 519 classes totaling 2,197 hours of training. An increase from FY20, however still a decrease from FY19, mostly due to COVID restrictions. There was a good report on overall training regardless of the reduction in State funding. Upon an analysis of these figures, we show an offering of more multiple day courses instead of one-day courses. This was done to keep the training cost for overtime down for our members and to offer more 'quality' courses, instead of courses just to increase our overall numbers. As mentioned before, we continued to have members certify their in-service training and on-line training through Tri-River. This procedure added additional courses and training hours to our totals for this fiscal year. It was a decision which required additional manpower on our part, however it provided member departments the opportunity to take advantage of the many services we could provide them.

The Tri-River Advisory Board has been actively involved in the management of the MTU. The Advisory Board meets monthly, ensuring that necessary high-quality training is provided to our member agencies. Tri-River continued to meet every month by switching to ZOOM meetings when necessary to comply with COVID guidelines. We have received excellent support from our member departments, especially in providing facilities to hold our classes. Most of our classes are conducted in facilities controlled or contracted through our members which has kept our rental cost down to \$0.00 for the fiscal year. We thank all of those who have supported our training efforts.

Our FY2021 audit was completed in September of 2021 by the accounting firm of Wermer, Rogers, Doran & Ruzon LLC. The Illinois Law Enforcement Training and Standards Board, (ILETSB) allowed MTU's to contract with their choice of accounting firms for this audit if they met the standards to comply with handling governmental agency audits. This firm is from the local Joliet area and has completed numerous governmental audits at the local and county governmental level. A copy of their final report is available upon request.

In Fiscal Year 2021, we continued to incorporate internet-based software into our

daily activities. This included incorporating standard forms into an Adobe format for fill in the blank use by our members. We have further moved along with the use of our training data base along with using email as the primary form of contact and announcements of our courses. Our web site continues to accept registration requests as well.

At the conclusion of FY21, Tri-River had a balance (reserve) of excess Local Funds, from unused local dues, in the amount of \$98,299.11, which was collected for FY2021 above our hard match requirement and excess cash added to balance our year end budget. Any excess funds will be held as a contingency fund, reserved for any future emergency expenses or training needs.

In FY2021, we completed a 13th year assisting the Training Board with Chicago Police Department training funds. Tri-River continued to assist the Training Board with processing approved payments for the Chicago Police Department. As in the past, all training vouchers continued to be approved by the Training Board prior to payment being made. The Training Board continued to issue Tri-River the funds for Chicago's In-Service Training Grant, and Tri-River would then pay the training related bills once approval was received from the Training Board and the Chicago Police Department. A total of \$375,000 was received for this fund for FY21 and \$431,679.01 was distributed during FY 2021 which left a balance of \$264,042.37. The balance includes funds carried over from FY20. Tri-River processed 34 different transactions related to the management of CPD Funds in FY21.

During FY15, ILETSB's CIT funds in the amount of \$130,360 were turned over to Tri-River for the administration of these funds per an agreement signed with the ILETSB. During FY21, the fund started with a balance of \$51,651.87 and ended the fiscal year with a balance of \$34,362.67 with 16 transactions during the year that were processed for the Training Board.

In Fiscal Year 2021, we had \$139,505.50 in grant sponsored courses. Homeland Security Grants \$26,765.65, IDOT Grants \$55,821.81, Audit Grant \$15,000.00 and CIT Grants \$41,918.04. These additional funds assisted Tri-River deliver additional specialized training classes. Many of these classes would have been financially prohibitive to offer our members without the award of these grants.

Due to unknowns regarding grant funds from the State, the Tri-River Advisory Board raised the yearly membership dues effective FY21. The dues increased from \$70.00 to \$100.00 per full time officer and \$30.00 to \$70.00 for part-time officers. The previous yearly dues fee had been in place for over eight years.

On behalf of Tri-River, it continues to be a privilege to serve the member agencies of
the Tri-River Police Training Region, MTU# 16, and the Illinois Law Enforcement
Training and Standards Board.
